

REGULATIONS
participation in the contest on DEMO-accounts

The contest period: from 09/07/18 to 31/08/18

(trading will start on July 09, 2018 at 00:00:01 GMT + 1 and will end on August 31, 2018 at 11:59:59 GMT + 1). Trading will be disabled before the contest begins.

Period of registration for the competition: 11/06/18 to 08/07/18

(registration for the contest will begin on June 11 00:00:01 GMT + 1 2018 and end on July 08, 2018 23:59:59 GMT + 1).

The prize fund of the contest is \$ 25,000 for 16 prize-winning!

Right to participate. General terms

Anyone who has reached the age of 18 years and over can take part in the competition.

Each participant of the contest must complete verification in the Personal Page <https://my.cliqfx.com/auth>

Each participant agrees to provide accurate data when registering and verifying the Personal Page. Providing forged information will lead to disqualification in the competition at any level.

The contestant has the right to register only one Personal Page for participation in the competition.

CLIQ FX has right to reject or disqualify any member who, at the discretion of CLIQ FX, is deemed to be involved in fraudulent or unfair trading activities, and including identifying any type of IP compliance between two or more participants (all these parameters are grounds for disqualification from any level of participation in this competition).

Trading conditions of the Demo account is

Each contestant will have the same trading conditions:

Server: CLIQ FX-Demo

Trading terminal: MetaTrader4

Account: DEMO-Contest

Leverage: 1: 100

The demonstrative conditional deposit provided by CLIQ FX for each participant will be \$10,000. (These funds have no monetary value and are provided solely for trading purposes in accordance with the rules of this competition).

The minimum trading volume that will be provided for the competition is 0.01 lot.

The maximum trading volume that will be provided for the competition is 100 lots.

The maximum number of simultaneously open positions / pending orders during the competition is 200.

The ranking of the contestants with their statistics will be available on the website cliqfx.com. Any contestant, before the start of the competition, can increase the initial deposit provided by CLIQ FX by sharing a link on the page with describing the "DEMO Account Contest" in his/her personal profiles on social networks: Facebook, Twitter, VK or Instagram - register the contest and mark up to 10 friends to whom the participant recommended participation in the CLIQ FX contest and, subsequently, they also became contestants.

To satisfy this criterion, a participant can receive an additional US \$ 50 contributed to the competitive Demo account for each registered friend (no more than 10 friends). The message should be public and should have 2 hashtags: one of them is the hashtag of the contest itself, #CliqFxContest, and the other has a hashtag of the alias, using which the participant registered to participate in the contest. For example, if you have registered under the alias "TraderKing", then the second hashtag should be #TraderKing. If you decide to use this option, you can request additional funds only once, and your initial deposit can be up to \$ 10,500. The competitive CLIQ FX will check the activity of Facebook, Twitter, VK and Instagram for the #CliqFxContest hashtag and allocate up to \$ 500 additional funds to the registered demo account of the contestant, which will be counted as starting profit and will be credited to the result (this surcharge will be advantage for the current contestant).

Competition conditions

Trading time: trades will start on July 8, 2018 at 00:00:01 GMT + 1 and will end on August 31, 2018 at 23:59:59 GMT + 1.

Number of transactions: 25 or more.

Total drawdown by equity (Maximal Drawdown): not more than 30%.

The possibility of using robots, software, advisers: is not allowed.

Arbitration: prohibited.

The minimum amount of profit in the transaction: without restrictions.

Minimum time for transaction completion: without restrictions.

Achieving the maximum possible increase in the deposit: without restrictions.

Determination of the winner

At the end of the competition, all open trades are automatically closed at current market prices. Within 3 days after the end of the competition, the audit will check the implementation of competitive conditions and the participants with the largest percentage increase in the deposit who also follow all other conditions fulfilled in this document are declared winners of the current competition at CLIQ FX.

In case if two or more contestants will have an equal percentage return from the initial balance at the end of the competition, the prize will be given in accordance with the prize places, and in case of their shortage will be divided equally among them.

The results of the competition will be displayed within 3 days after the end of the competition and all the verification procedures are completed.

To win a prize, each winner must have an open real account in CLIQ FX's Personal Page.

The prize money is credited to the real trading account of winner in the section "Credit" of CLIQ FX within 30 calendar days after the announcement of the winners of the competition and is considered as investment by CLIQ FX. In case the winner can not open a real account within 30 calendar days after the winner's announcement, he will be disqualified.
